Jury—Verdict—Defendant convicted of rape by majority verdict—Verdict delivered following Watson direction—Proper exercise of judge’s discretion as to whether to give the direction—Whether judge should have invited submissions from counsel before giving the direction—Effect of deviating from the strict wording of the direction—Whether direction in the form given placed improper pressure on the jury to reach a verdict

Reporting restrictions—Breach of—Strict liability offence—Offence committed by any person “who publishes any matter”—Article published in local newspapers identifying school where victim a pupil—Editor of offending newspaper charged with offence—Whether editor a person “who publishes”—Children and Young Persons Act 1933 (23 & 24 Geo.5, c.12) s.39(2)

Queen’s Bench Divisional Court [2015] 2 Cr. App. R. 18

Tort—Cause of action—Harassment—Defendant making hostile and defamatory comments about husband—Defendant posting private home address and identifying private phone number of husband and wife—Wife seeking damages for harassment as victim—Judge dismissing claim on grounds wife not targeted and thus no course of conduct established—Whether requirement of statutory tort of harassment that claimant be target of perpetrator's conduct—Protection from Harassment Act 1997(c.40) ss.1(1),3(1), 7(3)

Trial—Unrepresented defendant—Prosecution closing speech—Defendant withdrawing instructions from counsel and solicitors during trial and representing himself—Prosecuting counsel making closing speech—Whether judge erred in allowing prosecution to make closing speech where defendant unrepresented—Whether conviction to be quashed
