*Legal aid—Choice of representative—Application to transfer—Crown Court judge refusing application to transfer legal representation order to different solicitors—Legal representation order revoked by judge on basis that impossible for existing solicitors to continue to act—Whether judge erring—Criminal Legal Aid (Determinations by a Court and Choice of Representative) Regulations 2013 (SI 2013/614) reg.14*

R. (Sanjari) v Crown Court at Birmingham

Queen's Bench Divisional Court [2015] 2 Cr. App. R. 30

*Legal professional privilege—Exceptions—Defendant having long history of harming himself and others—Risk of defendant harming himself during court conferences with counsel—Judge ordering that conferences take place in presence of nurses from secure hospital—Whether situation within exceptions to common law right to consult privately with lawyers—Whether equivalent right under Human Rights Convention absolute—Whether right breached—Human Rights Act 1998 (c.42) Sch.1 Pt I art.6*

R. v Brown (Edward)

Court of Appeal (Criminal Division) [2015] 2 Cr. App. R. 31

*Proceeds of crime—“Converting criminal property”—Defendant apparently having no legitimate source of income—Whether sufficient for Crown to show money in question having no lawful origin—Whether proof required of particular type of criminal conduct generating benefit represented—Proceeds of Crime Act 2002 (c.29) ss.327, 328, 340*

R. v Kuchhadia

Court of Appeal (Criminal Division) [2015] 2 Cr. App. R. 32

*Sexual offence—Rape—Consent—Whether apparent consent genuine where evidence of complainant having been groomed for sexual exploitation—Sexual Offences Act 2003 (c.42) s.1*

*Sexual offence—Trafficking for sexual exploitation—Defendant alleged to have facilitated “travel” by driving victims to locations where sexual activity occurred—Journeys unplanned and of short duration—Meaning of “travel”—Whether de minimis principle excluding travel over minimum distance or duration from statutory provision—Sexual Offences Act 2003 (c.42) s.58*

R. v Ali (Yasir)

Court of Appeal (Criminal Division) [2015] 2 Cr. App. R. 33

*Terrorism—Power to question at port or border—No requirement of suspicion—Wilful failure to comply with duty to answer questions—Defendant questioned at airport by police under statutory powers for purpose of determining whether she appeared to be concerned in acts of terrorism—Defendant charged with wilful failure to comply with duty to answer questions—Whether powers infringing defendant’s rights to liberty or private and family life, or privilege against self-incrimination—Human Rights Act 1998 (c.42) Sch.1 Pt I arts 5, 6, 8—Terrorism Act 2000 (c.11) (as amended by Anti-terrorism, Crime and Security Act 2001 (c.24) ss.118(2)(3)), 53(1), Sch.7*
